PLEASE READ AND ACKNOWLEDGE AND INITIAL AT BOTTOM RIGHT

- Deposit per space is \$ 150.00. Will receive deposit back at end of term (prior notice must be given). Refunds will be refunded electronically within 7-10 days.
- Rent due date is always counted as day 1 ; starts on the 1st of the month.
- If rent fees are not paid before 9:00 am on the morning of the 5th day, tenant agrees to pay late fees of \$25.00 + \$10.00 per day until rent is paid in full
- No discounts or refunds on monthly rents. Rent is charged for the month only
- Sokay's RV Park reserves the right to refuse service to anyone
- If rent is paid prior to move-in and, for any reason, tenant does not move into Sokay's RV Park on the designated date or into designated space, rent paid will be non-refundable.
- Any NSF checks will be charged a service fee plus late fee totaling \$45 and tenant will only be allowed to pay with cash, cashier's check, or money order for the remainder of their stay.
- All rent and electric fees are to be paid on or before rent due date. Electric fees included with monthly rate is up to \$50.00. If tenant is above the usage of \$50.00 in electrical, tenant is responsible for the difference and due when rent is paid on the 1st of the month. Meter reading documents will be given with invoice monthly.
- Designated date or space cannot be changed without park management approval. Must not move into another space in our park without prior approval.
- If your departure date extends into the next month, the rent will be due for the following month and will be charged.
- If tenant pays his/her rent and decides to move out before months end, the monthly rent is non-refundable.
- Tenant agrees to pay additional fee of \$50 per person per month for more than 2 people over age of 2.
- Park will not be responsible for any damage to unprotected RVs, vehicles or personal belongings.

- **Sokay's RV Park assumes no responsibility for injury, accidents or losses from any cause. We are not responsible for loss of personal property or for accidents of any nature. Park at your own risk.**
- **Sokay's RV Park will not be responsible or liable for any damage to recreational vehicles, personal vehicles or personal property of any kind.**
- **Tenant acknowledges that if mandatory evacuation is ordered for Cameron Parish, the tenant is responsible for moving all belongings off the premises. Failure to comply will be at the expense of the tenant. (Ex: Rv's, vehicles, trailers will be towed at owner expense)**
- **RV Hookup:** Tenant agrees to use an electrical surge protector.

THE FOLLOWING ARE NOT PERMITTED:

- Changing motor oil
- Working on vehicles (unless approved by management)
- Washing vehicles on premises
- Ground fires or pits (areas will be designated for this)
- Laundry lines or hanging clothes outside
- Liquid waste of any kind dumped on the premises or trash bins.
- Recreational vehicles not be used onsite (gravel or green space) Ex: 4 wheelers, etc.
- Firearms and fireworks are prohibited by local ordinance
- No glass bottles are allowed on green space/public area or gravel. (this is to ensure safety to everyone)
